President's Letter

During our big snow storm in December, I spent time in between shoveling snow to catch up on old West Wing episodes. The above quote from the season one finale really caught my attention. It describes so perfectly how our community is able to continuously improve itself. We have been fortunate over the past several years that whenever the neighborhood had a need, someone has stepped up. Be it our 60th anniversary picnic, the Fort Drive project, the repaving projects, or the various social events the JMCA puts on, someone has always stepped forward to lead.

As we prepare for the new year, we are at serious risk of taking a step back from this trend.

In March, I and at least three others on the JMCA board will be stepping down from our positions. We have also seen a slow but steady retreat in our attendance numbers at the general meetings. Our website hosting will be increasing as we transition to a new webhost and complete the relaunch of the site. This new website will allow us to provide more value and content for our paid members. Our social events, the crown jewel of the work the JMCA does, are paid for by your dues. In the back of this issue, you will find your annual membership form. I hope that you will take a moment to fill it out and send in your dues. They, and your time, are the

lifeblood of the association.

There are many decisions to be made just over the horizon. I hope that you will step forward to help us make them.

County Planning Review of Huntington Station Strip Mall

Lindsay A. Mason of the Fairfax County Department of Planning & Zoning gave a presentation to JMCA at a special meeting December 15. Fairfax County is doing an out-of-cycle review of the part of Jefferson Manor bounded by North Kings Highway, Jefferson Drive, Monticello Road, and Fort Drive,

which includes the Huntington Station strip mall, the garden apartments, and several duplex homes. The County is considering whether to allow denser development, given this location's close proximity to the Metro station.

Ms. Mason showed PowerPoint slides showing several initial options being discussed by the planning team, with density (Floor Area ratio, or

FAR) ranging from 2.0 to 3.0 FAR, maximum building height from 8 to 14 stories, different mixes of residential (apartments and/or townhouses) and business, and above-ground parking. Some of the options shown would entail displacing several homes on Farmington Drive and Monticello Road (but she emphasized this would not be done without owners' approval). Ms. Mason stressed that these were initial thoughts, and could be adjusted based on, among other things, community input. In the following discussion, residents expressed concerns

about the potential impact of a move to denser development on local schools, noise, and vehicular and pedestrian traffic on North Kings Highway and Fort Drive. Some residents worried about higher buildings blocking sunlight in the neighborhood; several residents expressed support for a plan with less-


> dense development, lower maximum height for buildings, and preservation of the Farmington Drive houses.

Based on input at the meeting and any followup input, the planning team will refine the options and write a draft plan (January/February), meet again with the Jefferson Manor community (March) to discuss the draft, further refine the

plan and incorporate a conservation plan (March—May). The final staff report will be presented at a Planning Commission public hearing in June, followed by a Fairfax County Board of Supervisors public hearing in July. ABCs of Neighborhood Parking Restrictions

Get better acquainted with the limitations imposed by Fairfax County Residential Parking Code at the JMCA General Meeting at Janet's Java on January 19. Officer Carol Mathieu, who patrols our streets to enforce the parking restrictions, will brief our residents on the code's provisions. For those of us that have unintentionally enriched the County's coffers, this promises to be an evening that pays back your time investment.

Energy Efficiency, VA State Rebates, and Household Energy Audit Offer

Pascale Maslin, an energy efficiency expert, spoke to the community association at our November meeting. She discussed ways to keep household utility bills down and reduce our overall carbon footprint.

She explained that a good way to start is by comparing your home energy bills with those of other houses of similar size. The key is to "sort out the top of the house" (i.e., attic insulation, as that is where much heat escapes). Replacing windows and furnaces/air conditioners need not be first steps if they are functioning properly and maintained. Installing programmable thermostats, putting insulation on hot water heaters and pipes, repairing leaking ducts, switching to compact fluorescent lights, and fixing leaking faucets/toilets are all fairly simple, do-it-yourself projects that can save significant amounts of energy. The Virginia state government and the federal government offer a range of rebates and/or tax credits for installing energy-efficient

equipment (although it appears that some of the state offers are currently in abeyance). More information can be found at http://www.dmme.virginia.gov/DE/ARRA-Public/SEPRebate.shtml.

The state government also offers up to \$250 rebates for household energy efficiency audits (although again, these rebates may be on hold at the moment).

Ms. Maslin's company performs household energy efficiency audits. She will offer 10% off her regular \$350 fee for JMCA residents, and will decrease the price to \$300 if she can schedule two or more JMCA houses together on the same trip. 2009 Budget Treasurer's Report


The official treasurer's report is submitted at the March general membership meeting, but here is a summary. I am pleased to report that our neighborhood association remains in good health, both in terms of finances and membership.

Membership

We had 103 members this year: 100 residents and 3 non-residents (one non-resident owns two separate properties). We had 30 new members this year, which is almost the same as last year (34). Although there are over 500 households in Jefferson Manor, not including the Huntington Garden Apartments on Fairhaven or the townhouses on Edgehill Court, local officials have assured us that our membership rate is still very high for Fairfax County neighborhood associations. Over 200 households have been JMCA members at some point during the past three years, so part of our work will be reminding people to re-join each year. We also hope to increase our membership numbers with participation from the apartments and townhouses that were welcomed into JMCA at the end of the summer.

For comparison, here are the membership numbers for the past three years:

2008: 122 households (121 residents, 1 non-residents) 2007: 86 households (83 residents, 3 non-residents) 2006: 108 households (102 residents, 6 non-residents) Here is a breakdown of our membership by street:




Budget


We began the year with roughly \$4,168. We end 2009 with a projected balance of \$5,587 (including pending payments and interest on a CD that matures this month). As the rough breakdown of our expenses indicates, we were able to reduce our event expenses this year (thank you, Social Committee!). The largest single expense item was our newsletter. For revenue, we continue to rely primarily on membership dues, donations, and newsletter advertising. We again owe Tom Rickert and Color Flooring Kitchen & Bath Design Center a special thank you for their consistent support with ads that provided the bulk of our advertising revenue.

Neighborhood Watch Update

Residents who are active on the listserv may have noticed an increase in the number of people who have mentioned someone going through their cars. In many cases the cars have been left unlocked, and little of value has been stolen. However, this is a disturbing trend that warrants our attention. All residents are encouraged to lock their car doors and call the police. If you see someone in the act of getting into your car, call 911. If after the fact you discover someone has been rifling through your vehicle, call the non-emergency number at 703-691-2131. It is very important that the police are aware of all incidents in the neighborhood, because that increases the number of patrols that go through our streets!

Traffic Calming Measures

The Traffic Calming Task Force met with Fairfax County Department of Transportation and Virginia Department of Transportation engineers to assess traffic calming measures available to the community and potential locations for these devices. The county indicated speed tables would be suitable for Fort Drive and Farmington Drive. We're working through options with them on Edgehill due to the regulations limiting installation of speed tables along roads with short distance between stop signs and intersections, and on narrow streets. The next step is for the county engineers to issue a proposal for review by the task force and presentation to the neighborhood for input and feedback.
