Land Use Update

The JMCA land use work on the future redevelopment of the Huntington Station strip mall and adjoining apartments is one step closer to completion.

After several years of community input, the county has published the comprehensive plan amendment based on the JMCA land use task force recommendations. In addition to an increase in allowed density on the site, the recommendations define the general land uses of the site, and include

environmental and community protections. On Monday, March 4 the staff report was approved by the Lee District Land Use Advisory Committee. As of this writing, we are preparing to bring it before the county Planning Commission on Thursday, March 14. Assuming approval, it will go before the county Board of Supervisors on April 9.

Illegal Sign Removal

Unlawful signs in the public rights-of-way have been a long-standing problem, but the number of signs has spiraled out of control in recent years and many residents in Fairfax County have voiced concern about unlawful signs.

The Board of Supervisors recently authorized the county to enter into a legal agreement with the Virginia Department of Transportation (VDOT) that allows the County to remove illegal signs from the public right-of-way.

The Office of the Sheriff will provide its Community Labor Force (CLF) (non-violent offenders accompanied by Sherriff's Deputies) to remove signs in identified areas of the County. CLF crews would remove all signs located in the designated public rights-of-way between Tuesdays and Fridays. Special event signs are only permitted from Saturday through Monday. If they are present during the weekdays they will be subject to removal. These signs will then be stored at a County facility for five days, which would allow the owner of the sign to reclaim it. After this five day period, unclaimed signs would be destroyed. Staff of the Office of the Sheriff and the Department of Code Compliance will monitor and record all costs associated with the implementation of this pilot program during its initial one year test period.

Sign Removal Facts

- ➤ Sign removal program will begin later this year after operations details are determined.
- > Signs will be removed between Tuesdays and Fridays.
- ➤ Special event signs (i.e., open houses, school plays, community meetings, etc.) are only permitted from Saturday through Monday.
- ➤ Signs will be removed from selected highways, not neighborhood streets.
- ➤ Under state law, some kinds of signs are permitted in public rights of way. These include no trespassing signs; Red Cross stations; signs at the intersections of two or more roads giving the distance or direction to a church, residence, or place of business; signs denoting only the name of a civic service club or church; and signs advertising or providing directions to a "special event."

Coming Out of Hibernation

As winter gives way to spring we may find ourselves more energetic, ready to break away from indoor activities and brave the great, green outdoors. Hours spent sitting can take their toll on our bodies. If we spend our days hunched over desks or in our cars, we may find our lower backs are sore. These exercises can help relieve tension in the lower back. The first exercise offers a respite in Child's Pose and a chance to expand the spine when you are fully extended. The second exercise opens the sides of the body which rarely are stretched during everyday activities. This pose also relieves tension in the lower back. Practice them consciously, taking care to stretch but not strain our backs.

Exercise 1: Sprouting Seed

Begin in Child's Pose: seated on your heels, forehead reaching toward the ground. If your head does not touch the ground, place pillows, books, or your fists on the floor to create a place for your forehead to rest. As you inhale rise up onto your knees reaching your arms to the ceiling. Keep your arms shoulder width apart, shoulder blades rolled down the back, armpits rolled in toward each other. Take several breaths. As

you exhale, lower your arms and return to Child's Pose. Take several breaths. As you inhale, rise up again. Repeat 10 times.

Exercise 2: Blown Palm

Standing tall, feet firmly planted on the ground. As you inhale raise your arms overhead. Keep your arms shoulder width apart, shoulder blades rolled down the back, armpits rolled in toward each other. As you inhale, lengthen your spine. As you exhale, bend to the right. Feel a stretch on both the left and right side of the body. If you feel scrunched, inhale up until you feel length. Take 5 breaths. Inhale back to center. Exhale as you bend left.

Practicing with your child?

For Exercise 1: Imagine you are seeds in the earth and as you are watered by the rain and warmed by the sun you sprout, take in the sunshine, and return to the earth.

For Exercise 2: Imagine you are palm trees firmly rooted in the earth, gently swaying in the breeze.
