On May 18<sup>th</sup>, I had the honor of representing Jefferson Manor at the dedication of the new Woodrow Wilson Bridge. Approximately 1400 people attended the ceremony, including Governor Ehrlich, Governor Kaine and Mayor Williams. The original Wilson Bridge was completed in 1961 and was designed to carry 75,000 people a day. Today, the bridge carries almost 200,000 people a day. At an estimated cost of \$2.4 billion, it is one of the largest infrastructure projects in the United States. Some very exciting things are happening in our community lately. You may have noticed the new "Jefferson Manor" and Neighborhood Watch signs posted at our neighborhood entrances. 

## In Memory of Bob Lowery

James Robert "Bob" Lowery died Tuesday, June 27, 2006. He was 86 years old. Bob was the second President of Jefferson Manor Civic Association, taking office in the 1960s and serving until the late 1990s. He fought for one-way streets to make space for street parking, and kept an eye on our small shopping center. He was a salesman for Mueller's Food, now called Best Foods, and retired in 1984. He was Chairman and co-founder of the Fairfax County Police Citizen's Advisory Committee. He also served on the Transportation & Safety Commission, the Board of Directors of the Neighborhood Watch, Inc., and the Lee District Land Advisory Committee. Bob was a devoted husband to his wife Ethel, visiting her daily at her nursing home for eight years.

As someone who knew him commented, Bob was from the old breed, volunteering his time to make life better for others. ## Parking Permits for 2006-2008

Old permits/decals expired on June 30<sup>th</sup>. If you did not receive an automatic renewal form, you must renew by telephone, mail or in person. Your vehicle must be registered with the Fairfax County Department of Transportation at a



Jefferson Manor street address to receive a parking decal.

- To renew by telephone, call 703-324-1100 (between 8 AM and 4:30 PM) and have your SSN or Driver's License Number handy.
- To renew by mail, send a COPY of your driver's license and vehicle registration to Department of Transportation, 12055 Government Center Pkwy, 10th Floor, Fairfax, VA 22035-5511.
- To renew in person, bring your driver's license and vehicle registration to the above address (Monday through Friday from 8 AM to 4:30 PM).

# We have several public parks & recreation centers near us.

- If you want to play miniature golf, practice hitting some baseballs or swim in a large wave pool, try Cameron Run Regional Park (4001 Eisenhower Ave, 703-960-0767).
- If you would rather go camping, use the marina or enjoy the paddleboats or play at the par-72 golf course, you might want to check out Pohick Bay Regional Park, approximately 30 minutes from Jefferson Manor. Travel south on Route 1 just a short distance past Fort Belvoir, make a left onto Gunston Road, then left onto Pohick Bay Drive (6501 Pohick Bay Drive, Lorton/Mason Neck, 703-339-6104).
- Just want to golf? Check out Greendale Golf Course (6700 Telegraph Rd, 703-971-6170), run by the Fairfax County Park Authority and about 3.5 miles from Jefferson Manor.

# There are two Fairfax County Recreation Centers nearby.

- Lee District Park & RECenter (6601 Telegraph Rd, 703-922-9841) is 2.5 miles from Jefferson Manor. It has baseball fields, a large indoor pool for all ages, plus diving boards, horseshoe pits, tennis courts, picnic areas and, during the summer, concerts every Wednesday evening starting at 7:30 PM.
- Mount Vernon RECenter (2017 Belle View Blvd, 703-768-3224) is about 2 miles from us. Here you can exercise, swim indoors and if you want to really cool off on a hot day, there's an ice skating rink.

## Hate having mosquitoes?

The key to getting rid of mosquitoes is to **eliminate** standing water. Mosquitoes don't need more than a cap full of water [or a constantly soggy or wet area] to lay their eggs, so getting rid of these areas is a priority. (1) Clean your gutters, (2) overturn buckets and watering cans when not in use, and (3) spray out your birdbath once a week. Anything that can hold water can breed mosquitoes.

Still have mosquitoes? Mosquitoes are notoriously bad fliers — so, if you don't have standing water on your property, ask your neighbors to check theirs. Use insect repellent and/or citronella candles for temporary relief.

### **Huntington Station Shopping Center Update**

Thank you to everyone who has provided input and followed developments regarding this issue. At its May 22<sup>nd</sup> meeting, the Lee District Area Plan Review Task Force voted to recommend that the Fairfax County Commission not amend the Comprehensive Plan as it applies to the Huntington Station shopping center site.

A.J. Dwoskin & Associates, owner of the shopping center, along with the owner of the Jefferson Gardens apartment complex, had hoped to get the plan amended to facilitate their plans for redevelopment of the site.

The JMCA Board of Directors supported the plan amendment proposal for various reasons detailed in position statements circulated previously. However, Fairfax County planning staff found several aspects of the proposed amendment to be problematic, and the Task Force viewed it unfavorably. At this time, the JMCA Board of Directors and the Land Use and Transportation Committees are developing a strategy to continue to advocate for neighborhood improvements following this setback.



# **Emergency Preparedness Begins at Home**

Recent world events such have shown us that emergencies can strike anywhere, occurring quickly and without warning. We must all be prepared for emergencies ranging from house fires and blackouts to hurricanes. Advance preparation will allow for quick reaction, better safeguarding our families and protecting our property. There are a few simple actions you can take to help your family better prepare.

#### Make a Family Communication and Emergency Plan

It is essential that each family should have an out-of-state contact that family members can call if separated during an emergency. The out-of-state contact should be far enough away that they may not be affected by the emergency. List important contact numbers such as your doctors, pharmacist, schools, daycare facilities, workplaces, etc. Copies of the plan should be kept at home, work, and your children's school. Discuss the types of disasters that are most likely to happen. Choose places to meet if you need to evacuate from your home. One meeting site should be just outside your home and the other should be outside the neighborhood. Each family member should know the address and phone number of the secondary evacuation site. You should also:

- √ Make sure you have adequate insurance.
- √ Show each family member how and when to turn off the water, gas, and electricity at the main switches. (Do not turn gas off unless advised by local officials.)
- √ Find out about the emergency plans at your workplace and your children's school or daycare.

#### **Build an Emergency Supply Kit**

An emergency supply kit should provide you with supplies to sustain yourself for 3-5 days and be mobile to expedite an evacuation or shelter-in-place.

#### Practice your plans

Every 6 months test your plans, contact numbers and conduct a practice drill.

#### **Evacuation**

Listen to radios or the TV during inclement weather or conditions that could potentially threaten the area. *Follow the directions of the local authorities.* If you are told to evacuate, take your prescriptions, emergency supply kit and pets. Be sure to lock your door. *Always follow all travel routes and advisories recommended by local officials.* 

Specific information can be obtained during an emergency from Fairfax County Government Emergency Information Line at 703-817-7771.
