# JMCA Wants You!



Are you a fundraising phenom? A grants guru? An event-planner extraordinaire? A consummate communicator? Your neighborhood needs your help!

JMCA board elections are coming up in March, and you have several opportunities to serve your community in 2024. The nominating committee is seeking volunteers for multiple board roles, including president, treasurer and director. Additionally, we could help with USE communications: both this newsletter and the <u>jeffersonmanor.org</u> website.

The role of president is, well, exactly what you think it is. The president presides over all meetings of the JMCA membership (six per year) and manages the association business. The president leads volunteers -- on and off the Board -- in advancing the interests of the neighborhood, planning and coordinating social and charitable activities, and providing information and services for neighborhood residents.

The treasurer's role is twofold: memberships and money. The treasurer has custody of all JMCA funds and keeps full and accurate accounts of all receipts and disbursements. She or he prepares an annual report of the cash receipts and disbursements for the prior calendar year (available at the annual March membership meeting). Included in those receipts is JMCA merchandise: The treasurer stores, maintains and sells shirts, annual membership stickers and the like at community events. The treasurer is also responsible for keeping a current list of the voting membership of the JMCA.

A director is elected to oversee, advise and direct the policies and procedures of the JMCA Board. In recent years, each Board member has led (with help!) planning and execution of one of our signature JMCA events -- the Al & Sandy Snyder Home and Garden Tour, the Holiday Extravaganza, and others -- and they pick up a newsletter delivery route six times a year.

The committee will develop the slate of candidates during January and February, with the election scheduled for March, after which the committee will dissolve. Just a few hours of volunteering to get you through the dark winter months and set JMCA on the right course for 2024.

# JMCA Dues Increase Proposal

At its December meeting, the board agreed to propose an annual dues change from \$20 per year to \$25 per year starting in 2024. Here are arguments for and against the plan, which will be voted on by members in the next meeting.

### MISGUIDED PLAN

The proposal to raise JMCA dues is misguided. Increasing the cost of membership makes our organization less accessible to the full range of households in our community. In our nearby neighborhoods, both the Huntington Community Association and Fair Haven Citizens Association have significantly lower annual dues -- \$12 and \$5 respectively.

If the proposed dues increase were to pass, the additional funds won't even cover the cost of one newsletter print run. JMCA should be exploring other revenue streams -- such as raising advertising rates -- to cover the cost of publishing this newsletter before we go about seeking that money from our neighbors.

JMCA has room to cut event costs and should be pursuing those before inflating membership dues. Would our Chili Cook-Off competition be any less fierce if the winner got bragging rights instead of a swanky apron? Doubtful. The Holiday Extravaganza recently featured a smorgasbord of potluck-style sweets instead of hundreds of dollars' worth of cookies from a commercial bakery. We should try more of that -- replacing cash expenses with community spirit -- before we squeeze a few more dollars from our neighbors. Just because everything else is more expensive now doesn't mean membership in your community association has to be.

### **NEEDED FOR SUPPORT**

Do you enjoy attending JMCA events? Have you gotten valuable information from the newsletter? Do you enjoy being a part of a vibrant active neighborhood? If the answer to any of these questions is yes, then you understand the value you get from your membership to the JMCA.

Over the last 10 years, the JMCA has vastly increased the number of events it holds, the size of those events and the amount of food and beverages provided. We have been lucky to have great neighbors, friends and sponsors who have supported us with food and beer - not to mention hours and hours of volunteer labor and materials. Despite these donations, costs have gone up. JMCA dues have not changed in the 12 years I have lived in the neighborhood, but the number of activities and level of engagement has increased significantly. As we all know, costs have risen for most things, including printing the newsletter. In order to continue to support this level of engagement within the community, the JMCA needs to raise more funds.

While we will continue to work with sponsors and advertisers to generate revenue, a modest dues increase is necessary. We will continue to reduce dues for seniors and offer multiyear discounts. The additional money will not cover our increased costs, but it will be a helpful source of revenue as we continue to leverage our local partners to provide great events for all, at no cost to participants.

# **BE SALT SMART**

Salting roads and sidewalks keeps us safe in winter weather, but it also leads to higher salt levels in the region's drinking water. Here's how some advice from Fairfax Water to help:

- Shovel early. Remove snow from pavements before it turns to ice. Use salt only after snow has been cleared and only in areas needed for safety.
- Use less. More salt does not mean more melting. A 12-ounce coffee mug of salt should be enough for a 20-foot driveway or about 10 sidewalk squares.
- Spread it evenly.
- Watch the temps. When it is colder than 15°F, do not apply winter salt – it will not work. In those cases, consider alternatives like sand or native bird seed.
- Look for leftovers. If you see salt remaining after the ice melts, sweep it into safe storage to keep out of our rivers and streams.
- Divert downspouts. If possible, channel downspout spillage to drain onto lawn areas rather than walks and driveways.

# **SNOW REMOVAL**

Check out the Fairfax County Guide to Snow: fairfaxcounty.gov/snow/

You'll find Virginia Department of Transportation Plow Tracker (<u>vdotplows.org</u>), a map that shows which streets get plowed, and a map showing who is responsible for walkways and sidewalks.

## CHRISTMAS TREE DISPOSAL

Fairfax County haulers will collect natural Christmas trees from January 2 to 15, 2024, for recycling. Lights, decorations, and stands must be removed to ensure collection. After January 15, please schedule a brush Special Pickup to have the natural Christmas tree removed.

To schedule a special pickup of bulk items, visit <a href="https://specialpickup.fairfaxcounty.gov/">https://specialpickup.fairfaxcounty.gov/</a> or call 703-802-3322. Our service includes 5 free special collections per customer, per fiscal year (July 1 - June 30).


